**NOTICE OF RECRUITMENT
FOURTH JUDICIAL DISTRICT
MAGISTRATE JUDGE – ADA COUNTY**

The Magistrates Commission of the Fourth Judicial District is seeking applicants for the position of Magistrate Judge for Ada County. The position will be chambered in the Ada County Courthouse in Boise, Idaho. The position will be initially designated to the family law docket, but may change depending on the court's docket needs.

Effective July 1, 2015, to be appointed to the office of magistrate judge, a person must, at the time of appointment, meet all of the following qualifications:

- (a) Be at least (30) thirty years of age;
- (b) Be a citizen of the United States;
- (c) Have been a legal resident of the state of Idaho for at least two (2) continuous years immediately preceding such appointment;
- (d) Have been in good standing as an active or judicial member of the Idaho state bar for at least two (2) continuous years immediately preceding such appointment;
- (e) Have held a license to practice law or held a judicial office in one (1) or more jurisdictions for at least five (5) continuous years immediately preceding such appointment;
- (f) Be a qualified elector of the State of Idaho; and
- (g) After appointment, reside in the county for which the magistrate judge is appointed.

The appointee may be assigned to hear cases throughout the judicial district, and may also be assigned outside the district by the Idaho Supreme Court. The annual salary for the position is \$123,400, plus state benefits.
